## POSITION DESCRIPTION AND DUTIES

Washington's legislature established an independent, impartial office to resolve inmate complaints, and to strengthen procedures and practices that lessen the possibility of actions occurring within the Department of Corrections (DOC) that may adversely impact the health, safety, welfare and rehabilitation of incarcerated individuals.

The purpose of the Office of Corrections Ombuds is to provide information to inmates and their families; promote public awareness and understanding of the rights and responsibilities of inmates; identify system issues and responses for the Governor and the Legislature to act upon; and ensure compliance with relevant statutes, rules and policies pertaining to corrections facilities, services and treatment of inmates.

The Communications Intern will be responsible for:

- Keeping office social media up-to-date
- Searching for and providing news clips regarding corrections to staff
- Developing brief office newsletters for stakeholders, policy makers, and incarcerated individuals
- Developing informational materials for incarcerated individual and family member self-advocacy

Depending on time, interest, skills, and abilities, the Communications Intern may be able to initiate and implement special projects.
