- * The Department of Health (DOH) is contracted by DSHS/WSH to receive reports and conduct investigations of:
 - Adverse Health Events (as defined in WAC 246-302-030, such as incidents involving patient death or serious injury);
 - Operational or Maintenance Events (as defined in WAC 246-320-151, such as a facility system malfunction in heating, ventilation, electrical or water supply affecting patient care);
 - A complaint that alleges an occurrence that poses immediate risk of patient harm;
 - A complaint that alleges an occurrence that demonstrates the extent or severity of the deficient practice limits WSH's capacity to furnish safe and effective services that meet the needs of patients but does not constitute an immediate risk of patient harm.
